



Terms and Conditions of Registers



COSRT Registers Terms and Conditions

If you wish to join the COSRT Registers (Register and Supervisor Register), or retain your current registration, you will must meet all current entry requirements and agree to terms and conditions below numbered 1 – 16 and as may be varied from time to time.

These terms and conditions do not replace the Terms and Conditions of Membership, or Declarations within your initial application and are in addition to them.

These terms and conditions apply to both the COSRT Register and the COSRT Supervisor Register.

Terms and conditions

1. I confirm that the information provided by me in my COSRT Membership Application Form and in any documentation related to annual renewal of membership is accurate, is not subject to any alteration or change and that by signing the agreement and declaration at the end of these Terms and Conditions I confirm and agree this is true.
2. I confirm and agree that I am in practice as a psychosexual and/or relationship therapist.
3. I confirm and agree that I will abide by Good Therapy – COSRT Code of Ethics and Practice, Good Therapy – COSRT Code of Ethics and Practice for Supervisors and any amendments or variations that may be made and any other statements that COSRT may make with regard to ethical practice and I also confirm and agree that I will abide by the Conduct Procedure.
4. I confirm and agree that I will ensure that my personal details are kept up to date, and understand that my personal information will be processed by COSRT in accordance with COSRT's Data Protection Policy (as published on the COSRT website at <https://www.cosrt.org.uk/members-and-professionals/gdpr/>).
5. I confirm and agree that I will ensure that I have adequate, current and ongoing professional indemnity insurance sufficient to my area(s) of practice – at a minimum level of £2,000,000.

6. I confirm and agree that I will ensure that I undertake and record continuing professional development (CPD) in line with the COSRT's requirements and will abide by and fully cooperate with any CPD audit.
7. I confirm and agree that I will ensure that I have appropriate supervision in place as required for the COSRT Membership category to which I belong.
8. I confirm and agree that I will notify my supervisor(s) that COSRT's Professional Standards Manager (hereinafter referred to as the PSM) may make contact to confirm that I have appropriate supervision in place.
9. I hereby agree, if requested, to provide the PSM with details of my supervisor(s), who may be contacted and I agree to give authority to that supervisor(s) to disclose such information that the PSM may require and I further give full and complete authority to the PSM to contact that supervisor(s) to request such information as may be required in accordance with supervision audit.
10. I confirm and agree that I will declare any character issues that may impact on my practice.
11. I confirm and agree that I understand that details of any professional conduct complaint made against me will be disclosed to relevant parties where deemed necessary or obligatory.
12. I confirm, acknowledge and agree that if I am removed from the Register my removal from the will be published.
13. I confirm that I understand and agree that withdrawal and/or suspension of registration as a result of professional conduct proceedings or failure to comply with any audits will result in the withdrawal or suspension of my registered status and the removal of my name from the Register. This may also result in the termination of my membership of COSRT.
14. I confirm that I am aware that the Register is accessible to the public and that my name, geographical location, registration status, membership status and professional conduct status is freely available.

15. I confirm that any information that I have given is truthful and that I have provided complete disclosure of all matters that may be relevant to the Registrar in determining whether I should be registered or retain registration on the Register.
16. I further confirm and agree that if there are any changes to any of the information I have given I will notify the PSM immediately at membership@cosrt.org.uk
